Contacting the MRC Secretary & Coordinator!

Repeater updates and frequency applications must be mailed or faxed. I will provide my FAX number upon request. You may also scan your documents and email the document.

You may use email to notify us of operational changes to your repeater like its now on the air or will be off the air for a period of time.

Proxy forms can be mailed or faxed, emailed scans are acceptable, however just a proxy statement is not..

I will continue to ask that you do the following before the meeting. It is much easier to resolve any issues in advance than at a meeting. I can spend more time to help come to a solution.

Secretary, Treasurers & Coordinators Note

Since the fall newsletter I have processed all of the update forms received., Many arrive after the October 31 deadline resulting in data entry right up to the ARRL deadline.

ARRL repeater directory submission was done with no problems, I ended up making several changes to the CTK export file to show APCO P25 and DSTAR systems.

No more DSTAR coordination's have been made, nor requested.

I also learned that there may be a federal grant that some counties are pursuing, that one of the action items is obtaining a 2-meter repeater. One of the central region counties is attempting to get a pair.

Over one weekend I received over 1200 spam emails resulting in my isolating my MRC email addresses from my regular address. We made the following changes to the MRC email addresses following this:

The @mrc.gen.mn.us domain will no longer accept any email, website remains in place. Email addressed to @mnrepeaters.org will continue to be valid. Names at this domain include coordinator, chair, vicechair and board that will be delivered to all of the MRC officers. The secretary@ email address has been eliminated, this reduces each officer's email address count to one group and one individual, further limiting the amount of spam. Email addresses on the website have been encoded with a simple javascript to prevent simple email harvesting. Future newsletters will not use the @ in the addresses so they will not be published directly.

Some policy items that we need to look at:

Members and non-members have requested that the frequency list be made available in text format so they may be imported into radio programming software. Historically this was done to make it more difficult for other web sites to use this data. Others used the data to attempt to do self-coordination due to the non-responsive MRC. We provide this information to the ARRL, they publish the repeater companion CD that will export the data. WAR is providing this data in text format along with other states. Do we want to revisit this policy.

I have received several requests for full duplex links, the MRC bandplan does not have provisions for that use. This would place one side in the 440-442 with a paired frequency +5.000 MHz in the 445-447 link sub-band. WAR is coordinating links like this. One area of concern would be for ATV users.

I would like to remove the \$5 newsletter only option from the membership application as it seems to cause confusion for both current members and new members. I would still recomend offering it for those who want it, however not place it on the forms Being the newsletter is on the website, this should not cause too much hardship and save me from asking the current and new regular/associate members who send \$5 for newsletters how they want to handle the extra \$5.

There has been little communications with surrounding states.

WAR has questioned the new ATV coordination citing MACC has adopted a sunset clause on new ATV repeaters in the 439-444 subband. Our recent bandplan allows it, so some research in order.
